

RESOLUTION NO. 2020-15

A RESOLUTION OF THE BOARD OF SUPERVISORS OF EAST LAMPETER TOWNSHIP,  
LANCASTER COUNTY, PENNSYLVANIA, TO CALL FOR THE GOVERNOR TO MOVE  
LANCASTER TO YELLOW, TO SUPPORT THE COUNTY COMMISSIONER'S EFFORTS  
TO REOPEN LANCASTER COUNTY, AND TO SUPPORT SENATE BILL 327  
REGARDING COVID -19 COUNTY EMERGENCY MITIGATION PLANS FOR  
BUSINESSES

WHEREAS, The Governor could move Lancaster county to the yellow phase as he has done with similar counties; and

WHEREAS, The majority of the Lancaster County Commissioners have expressed a desire to reopen Lancaster County; and

WHEREAS, Senate Bill #327, if enacted into law would authorize the County Governing body to develop and implement a Countywide plan to mitigate the spread of Covid -19 for businesses identified as essential critical infrastructure; and

WHEREAS, Senate Bill #327, if enacted into law would also authorize the County Governing body to develop and implement a Countywide plan to mitigate the spread of Covid – 19 for businesses not identified as essential critical infrastructure; and

WHEREAS, Senate Bill #327, if enacted into law would allow all businesses that comply with the requirements of the County mitigation plan to operate and permit their employees and

customers to leave their residences for the purpose of performing work for the business or to patronize the business.

NOW, THEREFORE BE IT RESOLVED, Governor Wolf should move Lancaster county to the yellow phase and allow for businesses to reopen following the same guidelines that essential businesses have been following; and

BE IT FURTHER RESOLVED, The Lancaster County Commissioners should take action and allow for businesses to reopen following the same guidelines that essential businesses have been following; and

BE IT FURTHER RESOLVED, that the East Lampeter Township Board of Supervisors hereby expresses their support for the provisions of Senate Bill #327 as written, and

BE IT FURTHER RESOLVED, that this Resolution shall be sent to Governor Thomas Wolf to request that he sign this bill, as passed by the legislature, into law.


